ON THE APPLICATION of Crowe MacKay & Company Ltd. (the "Proposal Trustee") in its capacity as proposal trustee of Go Flooring Ltd., coming on for hearing at Vancouver, British Columbia on October 11, 2024 and on hearing Lee J. Marriner, counsel for the Proposal Trustee, Nikhil Pandey, counsel for His Majesty the King in Right of Canada, and Irfan Walji, director of Go Flooring Ltd.:

THIS COURT ORDERS AND DECLARES that:

1. Pursuant to section 50(12) of the *Bankruptcy and Insolvency Act*, R.S.C. 1985, c. B-3 (the “*BIA*”), the proposal of Go Flooring Ltd. dated October 7, 2024 is deemed to have been refused by the creditors.
2. The Proposal Trustee is relieved of the requirement to take the steps described in sections 50(6), 51(1) and 62(1) (as it relates to filing the prescribed statement of affairs) of the *BIA*. Notwithstanding any appeal brought in respect of a declaration made pursuant to section 50(12) of the *BIA*, this paragraph of the order is subject to provisional execution pursuant to section 195 of the *BIA*.



3. Endorsement of this order by counsel and parties appearing at the hearing, except counsel for the Proposal Trustee, is dispensed with.

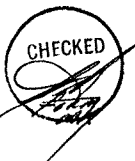
