I. INTRODUCTION

- 1. On July 11, 2024 (the "Filing Date"), Go Flooring Ltd. (the "Company") filed a Notice of Intention to Make a Proposal (the "NOI") pursuant to subsection 50.4(1) of the Bankruptcy and the Insolvency Act R.S.C.1985, c. B-3 (the "BIA") and Crowe MacKay & Company Ltd. consented to act as Trustee under the Proposal (the "Proposal Trustee").
- 2. Pursuant to section 50.4(8) of the BIA, the initial stay period in the proposal proceedings is from July 11, 2024 to August 10, 2024 (the "Stay Period").
- 3. A copy of the Certificate of Filing of the NOI issued by the Office of the Superintendent of Bankruptcy is attached hereto as **Appendix "A"**.

II. PURPOSE OF REPORT

- 4. The purpose of this report by the Proposal Trustee (the "First Report") is to provide this Honourable Court and the Company's stakeholders with:
 - a. information regarding the Company's current operations and certain matters relating thereto;
 - b. the Company's cash flow projection for the 15-week period from July 11, 2024 to October 20, 2024; and,
 - c. information and the Proposal Trustee's recommendations with respect to the Company's application to this Honourable Court for an Order authorizing and approving, among other things, the following:
 - i. granting an Administration Charge in the amount of \$150,000;
 - ii. allowing the sale of certain redundant and non-material assets, with the prior written consent of the Proposal Trustee, among others;
 - iii. allowing the proposed payment of a pre-NOI filing obligation in the amount of in or around \$25K on the basis that it is critical for the Company's continued operations; and.
 - iv. extending the Initial Stay Period for an additional 45 days from August 10, 2024 to September 24, 2024.

III. TERMS OF REFERENCE

5. In preparing this First Report, the Proposal Trustee has necessarily relied upon unaudited financial and other information provided by the Company, the Company's books and records, and discussions with management of the Company (collectively, the "Information"), namely Mr. Irfan Walji and Ms. Jennifer Grant (together, "Management").

- Proposal Trustee's First Report to Court
- 6. The Proposal Trustee has not audited, reviewed or otherwise attempted to verify the accuracy or completeness of the Information in a manner that would wholly or partially comply with Generally Accepted Auditing Standards pursuant to the Chartered Professional Accountants Handbook. Accordingly, the Proposal Trustee expresses no opinion and does not provide any other form of assurance on the accuracy and/or completeness of any information used to prepare this First Report.
- 7. Certain of the information referred to in this First Report consists of financial forecasts and/or projections prepared by the Company. An examination or review of the financial forecasts/projections and procedures as outlined by the Chartered Professional Accountants of Canada has not been performed by the Proposal Trustee. Readers are cautioned that since financial forecasts and/or projections are based upon assumptions of future events and conditions that are not ascertainable, actual results may vary and the variations could be material.

IV. COMPANY BACKGROUND AND OPERATIONS

- 8. The Company was incorporated in the province of British Columbia on December 3, 2014 and is a subcontractor to restoration companies which carries out business under the trade name "Go Flooring & Trades".
- 9. The Company's primary customers are restoration companies who are retained by insurance companies to assess and restore residential and commercial properties that have suffered damage due to events such as fires, floods, and hurricanes. These aforementioned restoration companies retain the Company to complete some or all of the repairs as needed.
- 10. The Company's sole director is Mr. Irfan Walji. Mr. Walji and Ms. Jennifer Grant act together as the Company's management ("Management").
- 11. Management advised that since 2019, the quantum and frequency of natural disasters have increased across Canada, and accordingly the Company sought to expand operations. Management advised that it went from one (1) location in British Columbia to sixteen (16) locations across five (5) provinces. This expansion saw the Company grow to around 70 employees.
- 12. Management advised that as a result of this rapid growth, the Company grew its annual revenues to \$21M for the fiscal year ending December 31, 2023. Management further advised that its revenue for the 5-month period ending May 31, 2024 was around \$6.4M.
- 13. Management advised that in or around 2022, the Company began to face financial issues as a result of the increased payroll from the growth in staff employed, increased overhead expenses, as well as unprofitable non-core business lines. Management advised that given the aforementioned financial issues, the Company was unable to meet its obligations in the ordinary course of business.

- 14. Management further advised that the rapid growth experienced in or around 2022 led to challenges with hiring experienced accounting staff, and that as a result the Company became non-compliant with its statutory filings for employee source deductions as well as Goods and Services Tax ("GST") with the Canada Revenue Agency (the "CRA").
- 15. Management advised that in order to address the financial difficulties the Company was facing, steps were taken to reduce the strain on the Company's cash flow which included, but was not limited to, the following:
 - a. closing 5 locations;
 - b. reducing operations in British Columbia, Alberta, Ontario and New Brunswick;
 - c. laying off or terminating around 19 employees; and,
 - d. attempting to obtain new financing with a major Canadian financial institution. This effort was ultimately unsuccessful.
- 16. Management advised that in or around February of 2024, the CRA began issuing Requirements to Pay pursuant to subsections 224(1), (1.1) and/or (3) of the *Income Tax Act* (the "RTPs") to certain of the Company's customers. Management further advised that, as a result of the RTPs, and the fact that customers were paying the CRA in place of the Company for outstanding receivables, the Company faced even further strain on its cash flows.
- 17. Management advised that as a result of the RTPs noted above, the Company was no longer able to meet its obligations in the ordinary course and was insolvent. Accordingly, the Company filed an NOI on July 11, 2024.

V. ASSETS AND LIABILITIES OF THE COMPANY

- 18. Despite efforts made by the Proposal Trustee, the Proposal Trustee has not received all of the information it had requested at the time this First Report was drafted. The Proposal Trustee understands that the delay in providing timely and accurate financial information is largely due to a lack of accounting support personnel. Management advised that arrangements have been made to retain a third party accounting professional who has experience with restructuring matters such as this to assist with, among other things, the monitoring and reporting requirements throughout this restructuring proceeding. This accounting professional was retained by the Company in or around the last week of July 2024. Although the Proposal Trustee is still waiting for information, the Proposal Trustee notes that there has been a significant improvement in the quality and timeliness of the information provided since the third party accounting professional has been retained.
- 19. As a result of the lack of accounting personnel noted above, the Proposal Trustee has not been able to conduct a detailed assessment of the Company's assets and liabilities at the date of this First Report. The below Information was prepared based on preliminary Information received from Management and is subject to change. A more detailed

assessment will be conducted by the Proposal Trustee over the course of its administration.

ASSETS

20. Given the issues with previous accounting personnel and the recent retainer of a third party accounting professional, as described above, the Company has been unable to provide the Proposal Trustee with more recent information for the purposes of this First Report and below is a summary of the Company's assets based on the financial statements as at December 31, 2023:

^{*}includes leasehold improvements of \$1,285,694 for 16 locations. However, since that time the Company has reduced its operating locations to 7.

Cash

21. Management advised that it did not have any cash on hand as at December 31, 2023. As at the Filing Date, Management advised that the Company had a cash balance in the amount of around \$5K.

Trade Accounts Receivable

22. Management advised that as at the Filing Date, the Company had trade accounts receivable of about \$1,490,000. A majority of the trade accounts receivable are from third party restoration companies who were retained by insurance companies. Management further advised that it has historically collected close to 100% of accounts receivable balances from restoration companies and believes that this will continue throughout the restructuring proceeding.

Inventory

23. Management advised that the Company has inventory with a book value totalling \$5,440,206 which is comprised of raw materials and work in progress with book costs of

approximately \$2,439,425 and \$3,000,780 respectively. Management advised that the book cost and the estimated realizable value of the finished goods is not materially different.

- 24. Management advised that a majority of the inventory (both raw materials and work in progress) are earmarked for specific jobs. Accordingly, management does not believe there would be any material recoveries from the work in progress inventory in the event of bankruptcy.
- 25. Based on preliminary information provided by the Company, the Proposal Trustee understands that the inventory of raw materials and work in progress are predominantly stored in warehouse facilities in Ottawa, Delta, Kelowna, Victoria, and Abbotsford.

Approximately, 30% of the raw materials is stored in the Company's physical locations, and the balance is stored in third party warehouses or specific supplier warehouses in the same cities as noted above.

Security Deposits

- 26. Management advised that the Company has security deposits totalling \$23,475 which is comprised of security deposits for its leased premises. Management advised that despite what was recorded on the balance sheet, it actually had security deposits totalling in or around \$122K. Management advised that this discrepancy was a result of the Company inadvertently expensing the security deposits as 'rent' rather than capitalizing the security deposits onto the balance sheet.
- 27. In the event of a bankruptcy, it is unclear what balance of the security deposits would be recoverable, if any at all.

Fixed Assets

28. Management has advised that the Company has the following fixed assets:

29. Management has advised that its fixed assets are comprised of machinery, equipment, flooring samples, racking, office furniture and computers, as well as leasehold improvements.

- 30. Based on preliminary information provided by the Company, the Proposal Trustee understands that most, if not all, of the above noted fixed assets are located Halifax, Belleville, Ottawa, Delta, Kelowna, Victoria, and Abbotsford.

 <u>Goodwill</u>
- 31. Management advised that the Company had goodwill of \$751,555 as at December 31, 2023. Management advised that the goodwill arose as a result of acquisitions of two entities operating in a similar business line, including a business in Calgary and another in Abbotsford.

LIABILITIES

Secured Creditors and Statutory Liabilities

32. Based on a *Personal Property Registry* ("PPR") search and information provided by Management, the Company is indebted, on a secured basis, to the following parties:

- Proposal Trustee's First Report to Court
- 33. Attached hereto as **Appendix "B"** is a copy of the PPR search for the Company as at June 27, 2024.
- 34. Based on available records, the Company is indebted to the CRA in the amount of approximately \$2.2M for unpaid employee source deductions. The Proposal Trustee understands that this amount includes the employee and employer portion of source deductions but may not include interest and penalties. This amount is subject to change as a trust examination has not yet been conducted by CRA. In the event of a Proposal, the Company will need to pay the amounts due for source deductions in full (including employee and employer portion plus interest and penalties) within six-months of Court approval of the Proposal unless otherwise extended by CRA. In the event of a bankruptcy, only the employee portion of this claim ranks as a deemed trust claim ahead of all other creditors including the Secured Creditors.
- 35. Management advised the Proposal Trustee that RBC had issued demands pursuant to section 244 of the BIA. The Proposal Trustee has not been provided with copies of these same demands, and accordingly it is unclear whether RBC is stayed by this restructuring proceeding.
- 36. Other than the Secured Creditors listed above, the Proposal Trustee is not aware of any other parties who may hold a secured or deemed trust claim against the Company.

Preferred Creditors

- 37. As at the Filing Date, Management advised that the Company may be indebted to approximately 8 employees with respect to unpaid commissions totaling approximately \$185,000, and it may be indebted to 51 employees for accrued vacation pay of approximately \$30,000. Most of the remaining employees are expected to take their accrued vacation during this ongoing restructuring process.
- 38. Employees could be entitled to a preferred claim for wages and vacation due within 6-months of the Filing Date pursuant to subsection 136(d) of the BIA to a maximum of \$2,000 per employee. The extent of the amounts due to the employees has yet to be determined.
- 39. As of the Filing Date, the Company operated and maintained ten leased locations. On or about July 19, 2024, the Company took steps to formally disclaim three leased locations. Below is a listing of the locations currently leased by the Company as of the date of this First Report.
 - a. Victoria, Delta, Abbotsford, Kelowna, Belleville, Ottawa and Halifax.
- 40. As of the Filing Date, Management advised that the Company was indebted to approximately eight of its landlords for arrears rent in the amount of approximately \$120,897. These landlords could be entitled to a preferred claim for rental arrears within

3-months of the Filing Date pursuant to subsection 136(f) of the BIA. The full extent of the landlords' potential preferred claim, if any at all, has yet to be determined.

41. Besides the potential preferred claims set out above, at this time the Proposal Trustee is not aware of any other parties who may hold a preferred claim pursuant to Section 136 of the BIA.

Unsecured Creditors

42. As at the Filing Date, the Company was indebted to in or around 250 parties with unsecured claims totaling approximately \$8,567,000. These parties consist primarily of trade suppliers, employees and various other vendors.

VI. ACTIVITIES OF THE COMPANY

- 43. Since the Filing Date, the Company's Management have engaged in, among other things, the following activities:
 - a. attended meetings with the Proposal Trustee to discuss the affairs of the Company, as well as the options available;
 - b. prepared and filed a projected cashflow statement for the 15-week period from July 11, 2024 to October 20, 2024 along with assumptions on or around July 19, 2024;
 - c. taken steps to reduce its ongoing expenditures in order to improve the Company's liquidity which included, but was not limited to, the following:
 - i. reducing operations to three (3) provinces, being British Columbia, Ontario and Nova Scotia;
 - ii. disclaimed 3 leases relating to leased warehouses and showrooms;
 - iii. temporarily laid off or terminated 9 employees; and,
 - iv. took steps to identify further leases and contracts to disclaim.
 - d. retained an experienced bookkeeper and accountant to assist the Company with improving its financial reporting, among other things; and,
 - e. stabilized the Company's operations and took steps to regain possession of its accounts receivables following the RTPs issued by CRA.

VII. ACTIVITIES OF THE PROPOSAL TRUSTEE

- 44. Since the Filing Date, the Proposal Trustee has engaged in, among other things, the following activities:
 - a. attended meetings with Management to discuss the affairs of the Company, as well as the options available;

- b. mailed out the initial notice to all known creditors and employees with claims of greater than \$250 on or about June 7, 2024 notifying them of the NOI proceedings pursuant to section 50.4(6) of the BIA, a copy of which is hereto attached as **Appendix "C"**;
- c. assisted Management in preparing a projected cashflow statement for the 15-week period from July 11, 2024 to October 20, 2024 which, along with assumptions, was filed with the Office of Superintendent of Bankruptcy on July 19, 2024 in accordance with section 50.4(2) of the BIA;
- d. had various discussion with the Company and its legal counsel relating to matters relevant to the various relief sought, as discussed below;
- e. issued letters to various stakeholders including customers with respect to the NOI filing, stay of proceedings and RTPs issued by the CRA;
- f. established and maintained a public website for these proceedings at: https://crowemackayco.ca/project/go-flooring-ltd/; and.
- g. prepared this First Report.

VIII. 15-WEEK CASH FLOW PROJECTION TO OCTOBER 20, 2024

- 45. The Company, with assistance of the Proposal Trustee, has prepared a 15-week cash flow for the period July 11, 2024 to October 20, 2024. A copy of the cash flow, along with the assumptions, is attached as **Appendix "D"** (the "**15-Week Cash Flow**").
- 46. The Proposal Trustee's review of the 15-Week Cash Flow consisted of inquiries, analytical procedures and discussions related to information supplied to the Proposal Trustee by Management. Since hypothetical assumptions need not be supported, the Proposal Trustee's procedures with respect to such assumptions were limited to evaluating whether they were consistent with the purpose of the 15-Week Cash Flow. The Proposal Trustee has also reviewed the support provided by Management for the probable assumptions and the preparation and presentation of the 15-Week Cash Flow.
- 47. Based on the Proposal Trustee's review, nothing has come to its attention that causes it to believe that, in all material respects:
 - a. the probable and hypothetical assumptions are not consistent with the purpose of the 15-Week Cash Flow;
 - as at the date of this First Report, the probable and hypothetical assumptions developed by Management are not suitably supported and consistent with the Company's plans or do not provide a reasonable basis for the 15-Week Cash Flow, given the probable and hypothetical assumptions; or,

- c. the 15-Week Cash Flow does not reflect the probable and hypothetical assumptions.
- 48. Based on the assumptions above, it is believed that the Company will have sufficient funds to operate during the Initial Stay Period as well as the First Extension period (defined and discussed in greater detail below).

IX. PROPOSAL TRUSTEE'S MONITORING OF COMPANY'S CASH FLOWS

- 49. Management has provided the Proposal Trustee with the actual cash flows for the period of July 11, 2024, to July 28, 2024. The Proposal Trustee reviewed actual cash flows and discussed the Company's ongoing operations with Management.
- 50. The Proposal Trustee is not aware of any material adverse variances between the actual cash flows and the 15-Week Cash Flow.
- Management advises that the Company is up to date with all of its filing and post-filing obligations to CRA and has continued to meet its other post-filing obligations in the ordinary course, together with its obligations under the *BIA*.

X. ADMINISTRATION CHARGE

- 52. The Company is seeking an administration charge over its property up to a maximum of \$150,000 to secure payment of the fees and disbursements of the Proposal Trustee, the Proposal Trustee's legal counsel and counsel for the Company (the "Administration Charge"). The Company is requesting that this Court issue an order stating that the Administration Charge is to rank ahead of all security, interests, liens, charges and encumbrances, claims of secured creditors, statutory or otherwise.
- 53. The Administration Charge is against all present and after-acquired assets, property and undertakings of the Company and shall rank in priority to all security interests, trusts, liens, charges, encumbrances, and other claims of secured creditors, statutory or otherwise, including all other court-ordered charges.
- 54. The Proposal Trustee has worked with the Company, its counsel and other professionals to determine the appropriate amount of the Administration Charge. It is reflective of the limited funds currently available to the Company and the fact that if the proposal proceedings are unsuccessful, the Proposal Trustee will have a significant amount of work to do, including transitioning the proceedings to a bankruptcy.
- 55. Presently, the Proposal Trustee holds a retainer \$75,000 to protect its fees and costs including the Proposal Trustee's legal counsel. The Company's legal counsel does not currently hold a retainer.

56. Given the tight liquidity constraints that the Company has been operating under, there is a heightened risk to the timely funding of the professional fees relating to these proceedings. These proceedings require the necessary involvement of professionals to guide and/or complete a successful proposal and, as such, it is the Proposal Trustee's respectful view that the Administration Charge is reasonable and appropriate to ensure the continued support of the respective professionals in the Company's efforts to restructure.

XI. SALE OF REDUNDANT OR NON-MATERIAL ASSETS

- As mentioned above, the Company intends on selling, disposing, or returning to the lessor (assuming no equity) certain pieces of redundant or non-material assets.
- 58. Management has advised that the Company has identified in or around 12 vehicles or pieces of equipment that it has deemed to be redundant. Accordingly, in an effort to reduce the Company's ongoing expenditures, it intends on selling, disposing or returning to the applicable lessor certain equipment or vehicles, as the case may be.
- 59. The Company is seeking an order authorizing it to, among other things, dispose of any of its redundant or non-material assets not exceeding \$15,000 in any one transaction or \$50,000 in the aggregate, provided that for each sale of an asset for an amount exceeding \$10,000, the Company shall first obtain the written approval of the Proposal Trustee, and RBC.
- 60. Any asset sold will vest with the purchaser of such asset free and clear of all encumbrances and the net proceeds of sale will be paid:
 - a. to any creditors having a security interest in such asset in order of their relative priority, subject to the Company first obtaining the written consent to such proposal payment from the Proposal Trustee; or,
 - b. to the Company for the purpose of funding its business operations if consented to by the creditor having the priority security interest in the asset.
- 61. The Proposal Trustee supports this relief sought and does not believe any stakeholders will be materially prejudiced by same in view of the consents required prior to the sale of any redundant assets and distributions. Further, the Proposal Trustee is of the view that disposing of redundant and unnecessary equipment may also assist the Company with streamlining its operations and improving its liquidity by reducing ongoing lease payment obligations which would ultimately enhance the likelihood of a viable Proposal.

XII. PAYMENT TO INSURANCE CLAIM COLLABORATIVE INC.

- 62. Management advised that the restoration industry requires that subcontractors, such as the Company, have a licence from a third party provider. The Company has a license with the Insurance Claim Collaborative Inc. ("ICC").
- 63. Management advised that it owes ICC in or around \$25,730.15 as at the Filing Date, and that if this amount is not paid then the ICC will terminate the Company's license. Should the Company's license be terminated, Management advised that this will also terminate the Company's ongoing contracts that form most of the Company's work in progress, and will cause the Company significant hardship as it will no longer be in a position to take on any new contracts. Management advised that the termination of the ICC license would ultimately cause the Company to cease operations entirely which would ultimately result in the Company not being in a position to file a viable Proposal and ultimately be deemed bankrupt.
- 64. The Company is seeking the authorization of this Honourable Court to pay the pre-filing amounts due to ICC as it believes that the license is critical to its ability to conduct its business during the restructuring process and thereafter, which it believes will benefit the Company's stakeholders generally.
- 65. On August 6, 2024, ICC wrote to the Company and advised that the sum of \$25,023.90 was outstanding as of July 11, 2024 and if not paid then the Company would not be able to remain an ongoing participant in the ICC retail membership replacement program. The Proposal Trustee was provided with a copy of the August 6, 2024 letter. Management advised that if the Company is not a member of the aforesaid program, it would not be able to continue business.
- 66. In view of the above, the Proposal Trustee supports the proposed payment to ICC.

XIII. EXTENSION TO THE STAY OF PROCEEDINGS

- 67. The Company is seeking a 45-day extension to the Initial Stay of Proceedings. This would extend the Initial Stay of Proceedings from August 10, 2024 to September 24, 2024 (the "First Extension").
- 68. Based on the 15-Week Cash Flow noted above, the Company is projecting to have sufficient funds to sustain operations, without the need for additional funding, up to and including the First Extension period.
- 69. The Proposal Trustee supports the Company's request for the First Extension of the Initial Stay Period for the following reasons:
 - a. the Company has acted in good faith and with due diligence;
 - b. the Company would likely be able to make a viable proposal if the Extension were to be granted; and,
 - c. no creditor would be materially prejudiced if the extension is granted.

XIV. PROPOSAL TRUSTEE'S RECOMMENDATIONS

- 70. Based on the current information made available by Management, the Proposal Trustee has the following comments in respect to the Company's application for approval of the relief sought:
 - a. the Administration Charge for the involvement of professionals is necessary to ensure the continued support and guidance to the Company in its pursuit of a successful proposal;
 - b. permitting the Company to sell redundant or non-material assets not exceeding \$15,000 in any one transaction or \$50,000 in the aggregate will allow the Company to reduce cash strain from non-essential operations;
 - c. the payment of a pre-NOI filing obligation to ICC in the amount of \$25,730.15 will allow for the continuation of the Company's license, which would in turn allow the Company to continue operating and take on new contracts from ICC; and,
 - d. the Extension is necessary for the Company to formulate a viable proposal.
- 71. For the above reasons, the Proposal Trustee respectfully recommends that this Honourable Court grant an Order for the relief sought by the Company.
