AFFIDAVIT

I, George Ian Thomas Munson, businessperson, of 3550 Highway 16 East, Terrace, British Columbia, AFFIRM THAT:

1. I am the sole director of Antler Creek Contracting Ltd. ("ACC") and as such I have personal knowledge of the facts hereinafter deposed to except where stated to be on information and belief, in which case I verily believe them to be true.
2. I affirm this Affidavit in support of ACC's application (the "**Application**") for an order:
 - (a) creating a charge (the "**Administration Charge**") on all assets and undertakings of ACC (the "**Property**") in favour of Crowe MacKay & Company Ltd. (the "**Proposal Trustee**"), counsel to the Proposal Trustee and counsel to ACC, in the aggregate amount of \$150,000 as security for their respective fees and disbursements that are related to these proposal proceedings (the "**Proposal Proceedings**");
 - (b) approving an interim lending agreement in respect of interim financing to be advanced to ACC and granting a corresponding charge on the Property in favour of the interim lender;

- (c) authorizing ACC, with the prior written approval of the Proposal Trustee, to make payments to certain suppliers (together, the “**Critical Suppliers**”) in respect of obligations incurred prior to April 14, 2025 (the “**Filing Date**”), where the Proposal Trustee is satisfied each such payment is necessary to ensure the continued supply of goods and services which are critical to ACC operations; and
 - (d) extending the time for ACC to file a proposal until June 27, 2025.
- 3. In preparing this Affidavit, I have relied in various instances on information provided by members of ACC’s accounting department, particularly as to the amounts of ACC’s financial obligations. I have read the Application and, based on my understanding of the matters addressed therein, and from my own review of ACC’s books and records, I believe that facts set forth in Part 2 of the Notice of Application, including those relating to ACC’s financial obligations, are true.
 - 4. Capitalized terms used and not defined in this Affidavit shall have the meanings given to them in the Application.

Preliminary Matters

- 5. ACC operates as a full service logging company with services including timber harvesting, road construction and hauling. ACC currently employs 37 full-time staff, including equipment operators, truck drivers, mechanics, road builders, supervisors and administrative personnel.
- 6. Attached hereto as Exhibit “A” is a BC Company Summary in respect of ACC conducted on April 24, 2025.
- 7. Attached hereto as Exhibit “B” are the results of a search of the BC Personal Property Registry (“**PPR**”) in respect of ACC conducted on April 24, 2025.
- 8. Attached hereto as Exhibit “C” is a copy of the Redacted Spreadsheet.

Current and Future Operations

9. ACC has three primary revenue sources at this time:
 - (a) 27,000m³ project under contract in the Kitimat, BC area that employs 12 people (including ACC employees and subcontractors). The project is expected to run for an additional three months and is anticipated to generate revenues of approximately \$1.8 million during that time;
 - (b) 10,000m³ project under contract in the Kitwanga, BC area that employs 11 ACC employees. The project is expected to run for another month and is anticipated to generate revenues of approximately \$416,000 during that time; and
 - (c) ACC timber sales – covering an area of 55,000m³ in the Terrace, BC area that employs 17 people (including ACC employees and subcontractors). These sales are expected to be completing over the next five months and are anticipated to generate revenues of approximately \$5.3 million during that time.
10. ACC has an additional contract with an existing client under negotiation in respect of a 40,000m³ project in the Terrace and Kitwanga, BC areas that is expected to employ 18 ACC employees and generate approximately \$3 million in revenues over a three month period.
11. ACC is also in the process of preparing and submitting bids for the following projects in the near future:
 - (a) 85,428m³ project in the Kispiox, BC area that is expected to employ 23 people (including ACC employees and subcontractors) and generate approximately \$8.4 million in revenues over a seven month period; and
 - (b) 24,748m³ project in the Terrace, BC area that is expected to employ 11 ACC employees and generate approximately \$2.4 million in revenues over a three month period.
12. ACC intends to continue servicing its current projects and bid for the new projects during the course of these Proposal Proceedings.

Interim Financing

13. Attached hereto as Exhibit "D" is a copy of ACC's Cash Flow Forecast.
14. As shown in the Cash Flow Forecast, there is an urgent need for interim financing in the amount of \$800,000 (the "**Interim Financing**") in order for ACC to continue operating and fund its restructuring costs. The Interim Financing will also be used to make payments to Critical Suppliers as detailed below.
15. ACC is facing severe liquidity issues and, absent immediate financing, will not be able to operate during these Proposal Proceedings, including in relation to its current projects, in which case there is no likelihood of a successful restructuring in the Proposal Proceedings.
16. ACC, in consultation with the Proposal Trustee, is in the process of finalizing a term sheet with certain prospective interim lenders in respect of the proposed Interim Financing on terms acceptable to it. Once complete, ACC shall serve the term sheet on all interested parties prior to the hearing of the Application.

Payments to Critical Suppliers

17. ACC seeks authorization from the Court to make payments on account of pre-filing obligations to suppliers that are fundamental to ACC's continued operations during these Proposal Proceedings.
18. There are no contracts between any of the Critical Suppliers and ACC; rather, the goods and services provided by the Critical Suppliers were, and will be, obtained pursuant to purchase orders.
19. ACC operates in a remote area of British Columbia, making it difficult, and in some cases impossible, to find alternative vendors that are able to ensure the timely, reliable and efficient provision of goods and services that ACC requires in order to generate revenue.
20. The Critical Suppliers are integral to ACC's ability to operate uninterrupted, including for the following reasons:

- (a) in each case the supplier is: (i) the sole supplier of a particular good or service; (ii) the lowest cost option available to ACC; or (iii) possesses a particular specialized skillset that is not readily available in the region; and
 - (b) being required to source products from outside the local region will lead to crippling turnaround times and significant cost inefficiencies.
21. ACC has been in discussions with each of the Critical Suppliers and believes they will each agree to continue to supply on credit if ACC is able to make some payment on account of the amount owed to them as at the Filing Date

Extension of Time to File Proposal

22. The filing by ACC of its Notice of Intention to File a Proposal was necessitated on an urgent basis due to concerns regarding creditor actions, including by Canada Revenue Agency, as well as the need for immediate funding in order to maintain operations. Accordingly, most of my time over the past week or so, and that of others involved in management at ACC, has been spent trying to navigate the issues relating to obtaining protection, securing financing, and ensuring creditors and customers are aware of ACC's filing and the implications of it.
23. It is far too early for ACC to have determined how these Proposal Proceedings will be concluded, including whether ACC is able to put a proposal to its creditors. ACC is working with its professional advisors and the Proposal Trustee to figure out what a restructuring will entail. I do expect that a sale and investment solicitation process will be brought to the court for approval in short order, and I understand such process generally takes at least two or so months to complete.
24. For the foregoing reasons, ACC requires time beyond the initial 30 day stay period in order for it to properly engage in a restructuring process and, if possible, make a proposal to its creditors. Provided ACC is able to obtain the interim financing it seeks, I see no prejudice to any creditor or other stakeholder in allowing ACC an additional 45 days to advance its restructuring.
